2) AN ORDINANCE AMENDING THE CODE OF THE CITY OF ALTOONA CHAPTER 646 ENTITLED "TAXATION" BY AMENDING ARTICLE VIII THEREOF ENTITLED, "EARNED INCOME AND NET PROFITS TAX", TO LEVY A TAX ON EARNED INCOME AND NET PROFITS OF RESIDENTS OF THE CITY OF ALTOONA AT THE FOLLOWING RATES FOR 2025: ONE PERCENT (1%) FOR GENERAL REVENUE PURPOSES BY AUTHORITY OF "THE LOCAL TAX ENABLING ACT" (ACT 511); THREE TENTHS OF ONE PERCENT (0.30%) FOR GENERAL REVENUE PURPOSES Altoona City Council Meeting Minutes 11/12/2024

BY AUTHORITY OF THE HOME RULE CHARTER AND OPTIONAL PLANS LAW; AND FOUR TENTHS OF ONE PERCENT (0.40%) TO DEFRAY COSTS RELATED TO THE PENSION PLANS OF THE CITY OF ALTOONA BY AUTHORITY OF THE MUNICIPAL PENSION PLAN FUNDING STANDARD AND RECOVERY ACT (ACT 205). IN ADDITION, SAID ORDINANCE WILL LEVY A TAX ON EARNED INCOME AND NET PROFITS OF CERTAIN NONRESIDENTS WHO WORK IN THE CITY OF ALTOONA AT THE FOLLOWING RATES: ONE PERCENT (1%) FOR GENERAL REVENUE PURPOSES BY AUTHORITY OF THE LOCAL TAX ENABLING ACT (ACT 511); AND FOUR TENTHS OF ONE PERCENT (0.40%) TO DEFRAY COSTS RELATED TO THE PENSION PLANS OF THE CITY OF ALTOONA BY AUTHORITY OF THE MUNICIPAL PENSION PLAN FUNDING STANDARD AND RECOVERY ACT (ACT 205). SAID ORDINANCE WILL CONTINUE TO REQUIRE TAX RETURNS; REQUIRE EMPLOYERS TO WITHHOLD AND REMIT TAX; CONTAINS DEFINITIONS, REFERENCES APPLICABLE STATUTES, DESIGNATES A TAX COLLECTOR, ESTABLISHES INTEREST, PENALTIES, COSTS AND FINES, PROVIDES FOR SEVERABILITY, A PURPOSE AND ESTABLISHES AN EFFECTIVE DATE. (EIT ORDINANCE - 2025)

3) AN ORDINANCE OF THE CITY OF ALTOONA, COUNTY OF BLAIR, COMMONWEALTH OF PENNSYLVANIA AMENDING CHAPTER 646 ENTITLED "TAXATION" AND IN PARTICULAR §646-96 "MILLAGE ESTABLISHED: ONGOING TAX" ESTABLISHING THE TAX RATE FOR ALL REAL ESTATE SUBJECT TO TAXATION LOCATED IN THE CITY OF ALTOONA, PENNSYLVANIA, AT A RATE OF 7.129 MILLS FOR THE YEAR 2025 AND CONTINUING THEREAFTER WITHOUT REENACTMENT UNTIL SAID RATE IS CHANGED BY CITY COUNCIL; THE ORDINANCE ALSO PROVIDES FOR A REAFFIRMATION OF THE REMAINDER OF CHAPTER 646; REPEAL OF ALL ORDINANCES OR PARTS OF LAWS IN CONFLICT THEREWITH; SEVERABILITY OF PROVISIONS AND AN EFFECTIVE DATE.
