CONSTRUCTION DOCUMENTS AND SUPPORTING DATA SHALL BE SUBMITTED IN TWO OR MORE SETS WITH EACH APPLICATION FOR A PERMIT. DRAWINGS SHALL SHOW LOCATION, USE, CAPACITY, AND PIPING ARRANGEMENT OF ALL EXISTING AND PROPOSED TANKS LOCATED, OR WHICH ARE TO BE LOCATED, ON THE PREMISES AND ALL ADJACENT STRUCTURES AND PROPERTY LINES. THE FUEL TYPE OF EACH TANK SHALL ALSO BE INCLUDED.					
A FEE OF \$100.00 PER TANK MUST BE PAID IN ADVANCE OF THE PROJECT DESCRIBED. A PERMIT WILL BE ISSUED UPON RECEIPT OF PAYMENT					
ISSUANCE:	ISSUANCE OF THIS PERMIT SHALL REQUIRE SPECIAL PERMISSION AFTER AN ON-SITE INSPECTION OF THE SITE AND MATERIALS, BY THE FIRE CHIEF OR FIRE INSPECTOR, OR DULY-AUTHORIZED AGENT; AND SHALL BE ISSUED FOR A FEE OF \$50.00 PER OCCURRENCE WHICH SHALL BE DEFINED WITHIN THE DATES OF THE PERMIT.				
PAYMENT OF FEE:	PAYMENT MAY BE MADE BY PRESENTING THE APPLICATION INVOICE AND AN APPROPRIATE METHOD OF PAYMENT TO THE FINANCE OFFICE LOCATED IN CITY HALL - 1301 12TH AVE SUITE 104 ALTOONA PA 16601. THE PERMIT WILL NOT BE ISSUED UNTIL PAYMENT IS RECEIVED.				
WEATHER:	FAVORABLE WEATHER. BURNING WILL NOT BE PERMITTED ON WINDY DAYS OR WHEN THERE IS A LOW ATMOSPHERIC CEILING OR WET CONDITIONS THAT WOULD CREATE SMOLDERING FIRES.				
GENERAL	SITE MUST BE 50 FEET FROM ANY STRUCTURE. POSITIVELY NO SMOLDERING. BURN ON THE ABOVE PROPERTY ONLY. APPLICANT MUST BE PRESENT WITH PERMIT FOR DURATION OF BURNING AND MUST HAVE EXTINGUISHING AGENT OR WATER ON SITE .				
PROHIBITED	THE FOLLOWING ITEMS SHALL NOT BE BURNED: CONSTRUCTION AND DEMOLITION WASTE, CANS, GARBAGE, RUBBER, ANIMAL WASTE, RUGS, DISPOSABLE DIAPERS, BOTTLES, FRESH GREENS, AND OIL-BASED MATERIALS, LEAVES. LEAVES MUST BE COMPOSTED AS REQUIRED BY PA STATE LAW.
