ADOPT-A-SPOT APPLICATION & AGREEMENT

DEAR COMMUNITY MEMBER,

THANK YOU FOR YOUR INTEREST IN THE ADOPT-A-SPOT PROGRAM. THE CITY OF ALTOONA OFFERS THIS PROGRAM, WHICH ENCOURAGES INDIVIDUALS, GROUPS AND BUSINESSES TO TAKE AN ACTIVE ROLE IN BEAUTIFYING AND MAINTAINING THEIR NEIGHBORHOODS.

WHAT IS IT?

UNDER THE PROGRAM, AN INDIVIDUAL OR A GROUP OF VOLUNTEERS MAY SELECT AN UNSIGHTLY AREA, SUCH AS A GRAFFITIED WALL OR LITTERED SIDEWALK, AND AGREE TO MAINTAIN IT GRAFFITI FREE AND/OR LITTER-FREE, FOR AN INDEFINITE PERIOD OF TIME. NO PLANTINGS OR IMPROVEMENTS ARE AUTHORIZED UNDER THIS PROGRAM.

WHO CAN ADOPT?

ANYONE CAN ADOPT A SPOT! INDIVIDUALS, NEIGHBORHOOD WATCH GROUPS, ORGANIZATIONS, COMMUNITY BEAUTIFICATION GROUPS, SCHOOLS, BUSINESSES, ETC., CAN PARTICIPATE IN THIS PROGRAM.

WHAT IS THE COST TO ADOPT-A-SPOT?

THERE IS NO COST. IT IS ABSOLUTELY FREE TO ADOPT-A-SPOT.

HOW DO I GET STARTED?

PLEASE COMPLETE THE ADOPT-A-SPOT NEIGHBORHOOD BEAUTIFICATION PARTNERSHIP AGREEMENT ATTACHED HERETO. THE CITY WILL FACILITATE THE ADOPTION OF THE AREAS BY PROVIDING THE NECESSARY PERMISSION (IN THE CASE OF CITY PROPERTY), WAIVER FORMS (FOR PRIVATE PROPERTY), AND INSTRUCTIONS ON APPROPRIATE MAINTENANCE PROCEDURES. THE CITY WILL ALSO FURNISH THE SUPPLIES NEEDED TO MAINTAIN THE AREA. SUPPLIES INCLUDE PAINT, ROLLERS, RAKES, BROOMS, SHOVELS, TRASH BAGS, ETC. (SOME OF WHICH WILL BE ON A LOAN-ONLY BASIS).

"ADOPT-A-SPOT" NEIGHBORHOOD BEAUTIFICATION PARTNERSHIP AGREEMENT

THE CITY OF ALTOONA GENUINELY APPRECIATES THE EFFORTS OF COMMUNITY-MINDED BUSINESSES, INDIVIDUALS, OR COMMUNITY ORGANIZATIONS COMMITTED TO A CLEANER ALTOONA. THIS AGREEMENT BETWEEN THE CITY AND ADOPTER:

TERMS

THE ADOPTER AGREES TO:

FOR GENERAL CLEANUP:

- 1. CLEAN AND MAINTAIN THE ADOPTED AREA(S) ON A REGULAR BASIS.
- 2. FOLLOW ALL RULES OF SAFETY AND USE COMMON SENSE. PAY SPECIAL ATTENTION TO THE SAFETY OF OTHER PEDESTRIANS AND AUTOMOBILE TRAFFIC. NEVER IMPEDE ANY PEDESTRIAN TRAFFIC ON THE PUBLIC AREA.
- 3. OBTAIN APPROVAL FOR ANY PLAQUES THAT MAY BE AFFIXED AT THE SITE. THE LANGUAGE SHALL NOT OFFER FOR SALE OR SOLICIT THE SALE OF ANY ANIMATE OR INANIMATE OBJECTS, ANY GOODS, WARES OR MERCHANDISE WHICH THE PUBLIC MAY PURCHASE AT ANY TIME. NEITHER SHALL SAID LANGUAGE MAKE REFERENCE TO ANY COMMERCIAL ESTABLISHMENT, PLACE OF BUSINESS, EVENT OR ENTERTAINMENT. ONLY THE PROGRAM NAME AND THE NAME OF THE ORGANIZATION/INDIVIDUAL RESPONSIBLE FOR MAINTENANCE SHALL BE USED ON ANY PLAQUE.
- 4. OBTAIN A COMPLETED WAIVER AND RELEASE OF CLAIMS FROM EACH PARTICIPANT.
- 5. CONTACT THE CITY OF ALTOONA TO END THE AGREEMENT IF YOU NO LONGER CAN MAINTAIN THE SPECIFIED LOCATION.

FOR GRAFFITI REMOVAL:

- 1. OBTAIN PERMISSION FROM THE PROPERTY OWNER PRIOR TO REMOVING ANY GRAFFITI ON PRIVATE PROPERTY.
- 2. MATCH THE COLOR OF PAINT AS CLOSELY AS POSSIBLE TO THE EXISTING COLOR.
- 3. CLEAN UP ANY MESS LEFT BEHIND, BEING ESPECIALLY CAUTIOUS OF SPILLING PAINT ON THE SIDEWALK.

THE CITY OF ALTOONA PUBLIC WORKS DEPARTMENT AGREES TO:

- 1. OBTAIN NECESSARY PERMISSION FOR ANY WORK OCCURRING ON PUBLIC PROPERTY.
- 2. LOAN HAND TOOLS TO THE GROUP WORKING ON THE BEAUTIFICATION PROJECT. SUCH ITEMS MAY INCLUDE RAKES, BROOMS, SHOVELS, HOES, ETC.
- 3. ARRANGE EXTRA CITY RESOURCES FOR CLEAN-UP DAY(S), WHEN APPROPRIATE.
