The Meeting was televised live on cable Public Access Channel 14 and rebroadcast Tuesday, June 11, 2024.

CALL TO ORDER – by Mayor Pacifico at 6:00 PM in Council Chambers SILENT MEDITATION PLEDGE OF ALLEGIANCE ROLL CALL – taken by City Clerk Linda Rickens Schellhammer Present: Council members Beatty, Butterbaugh, Clinich, Ellis, Ickes, Kelley and Mayor Pacifico

PRESENTATIONS – Phyllis Baker, Community Engagement/Development Director & Frank Kopriva, Executive Program Director of the Blair Regional YMCA discussed the Angie Gioiosa 4th of July Memorial Race that is held in Downtown Altoona and thanked the City for their assistance

Attorney Jens Damgaard, Eckert Seamans discussed the proposed City Ordinance Approving Guaranty for the Altoona Water Authority Pennvest Loan for the Logan Boulevard Waterline Replacement Project

Mayor Pacifico announced that Council held an Executive Session May 13th for potential litigation, real estate and personnel matters.

ALL PUBLIC COMMENT

Dr. Elias Rifkah spoke about the property that is behind his Chestnut Avenue office and pain management clinic on the 100 block of Lexington Avenue that is currently a playground that will become low-income housing and eliminate the playground; a letter was also submitted

Steve Hess with an accounting office at 127 Lexington Avenue stated with the playground closing for a housing development project, the kids are playing in his office parking lot and asked Council to do something about the housing project and the playground; a letter was also submitted

Paul Mingh spoke on behalf of his mother who has been a resident of her home on 36th Street since 1986; a letter was received from the Altoona Water Authority regarding a sewer bill that had not been paid since 2003; Mr. Mingh stated this is the AWA's clerical error and not his mother's fault; he asked Mayor and Council to contact AWA about this matter and stated they will be attending the next AWA board meeting

INCURRING "LEASE RENTAL DEBT," AS DEFINED IN THE PENNSYLVANIA LOCAL GOVERNMENT UNIT DEBT ACT, IN A PRINCIPAL AMOUNT NOT TO EXCEED \$7,500,000, EVIDENCED BY ITS GUARANTY OF 100% OF THE PAYMENTS DUE UNDER A "DEBT OBLIGATION" OF THE ALTOONA WATER AUTHORITY ISSUED TO THE PENNSYLVANIA INFRASTRUCTURE INVESTMENT AUTHORITY (PENNVEST), IN CONNECTION WITH THE WATER SYSTEM OPERATED BY THE AUTHORITY, AND PAY RELATED EXPENSES; AUTHORIZING A GUARANTY AGREEMENT, BY AND AMONG THIS CITY, AS GUARANTOR, THE AUTHORITY, AND PENNVEST, AS LENDER, SECURING THE DEBT OBLIGATION; PLEDGING (1) CERTAIN WATER SYSTEM LEASE REVENUES OF THIS CITY, AND (2) THE FULL FAITH, CREDIT, AND TAXING POWER OF THIS CITY, IN SUPPORT OF ITS GUARANTY; APPOINTING A

Councilman Kelley thanked AFD and APD for attending and participating in Jaffa Community Days; Senate Bill 1236 involves squatters and gives landlords and others assistance

Councilman Ickes thanked Overflow Church for the clean ups held downtown in May

Councilman Butterbaugh stated there are many projects taking place throughout the City over the summer and there will also be paving and asked the public to be patient

Vice-Mayor Ellis thanked Overflow Church for their Wednesday clean ups in May; also, the clean ups produced 10 roll offs and thanks to Burgmeier for donating these; the clean ups targeted Kettle Street to 12th Street and 7th Avenue to 1st Avenue and had a significant impact; during the project four homes received work; Vice Mayor Ellis stated as of today, Team Effort started programs across the County and they have taken on projects to help people get out of code issues; also, thank you to the Blair County Commissioners for their \$30,000 donation to Team Effort and \$50,000 commitment to help people get out of code issues; this is a grant program available for \$5,000 per person per household (owner occupied)

Councilman Beatty stated he spent a few days at Prospect Pool and the Blair Regional YMCA is doing a great job and the pool running well and it looks good; the diving board is a hit and it is always being used; the Redevelopment Authority has two RFP's on the City website regarding the rehab of two properties and encouraged people to view them

Councilwoman Clinich thanked APD and AFD for a very nice community event she participated in at Baker School recently
