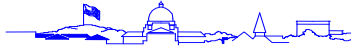

**General Provisions:**

1. All work shall conform to the City of Altoona Floodplain Ordinance.
2. No work of any kind may start until a floodplain permit is issued.
3. The permit may revoked if any false statements are made herein.
4. If revoked, all work must cease until permit is reissued.
5. Development shall not be used occupied until a Certificate of Compliance is issued.
6. The permit will expire if no work is commenced within six months of issuance.
7. Applicant is hereby informed that other permits may be required to fulfill local, state and federal regulatory requirements.
8. Applicant hereby gives consent to the Local Administrator or his/her representative to make reasonable inspections required to verify compliance.
9. THE APPLICANT, CERTIFY THAT ALL STATEMENTS HEREIN AND IN ATTACHMENTS TO THIS APPLICATION ARE, TO THE BEST OF MY KNOWLEDGE, TRUE AND ACCURATE.
